**SINGLES 9 PIN NO-TAP TOURNAMENT RULES**

1. USBC Tournament Rules and Regulations shall govern the conduct of this Tournament.
2. **ELIGIBILITY:** All USBC members certified by the Upper Shenandoah Valley USBC Associations in good standing are eligible to participate in this tournament. Bowlers who are not members of USV can qualify for entry by paying an affiliate membership of \$25.00, \$10.00, \$9.00.
3. **TIME PREFERENCE:** Entries will be scheduled in order of receipt. Saturday: 10:00 am, 1:00 pm and 4:00 p.m. Lanes will NOT be redressed after first squad.
4. **PARTICIPATION:** Bowlers entered must complete all games to cash any prizes. Bowlers may cash as many times as you bowl.
5. **TOURNAMENT AVERAGE:** Entrants will use their highest USBC Adult certified Bowl.com average based on a minimum of 21 games for 2024/2025 season, whether winter or summer. If no last season average, use the current highest USBC certified average, 21 games or more as of November 28, 2025. (If the submitted average is different than the correct average, the bowler will automatically be reclassified with the handicap for the corrected average. (USBC Rule 319c and 319d does apply) Any bowler with no average will use highest bowl.com average from up to 3-years past; exceptions can be made by the Tournament Manager.

**ALL AVERAGES MUST BE VERIFIED PRIOR TO BOWLING.** Association yearbooks' or secretaries' verification will be accepted. USBC Rule 319A (2) will apply. If a bowler's average for at least 21 games as of the tournament has increased by 10 pins or more the current average must be used.

1. **HANDICAP:** The handicap shall be 80% of the difference between the individual average and 200, based on 4 games for both male and female. GAME WITH HANDICAP WILL NOT EXCEED 300.
2. **ORDER OF BOWLING:** You will bowl as the same letter on each lane and move 1 pair to the right after each game, totaling 4 games. .
3. **ENTRY REQUIREMENTS:** . All fees must accompany the entry form. Make checks, money orders, and certified checks payable to Upper Shenandoah Valley. Cash is also accepted. Returned check fee is \$35.00. .
4. **PRIZE MONEY AND DISTRIBUTION:** Prize money shall be paid on a handicap basis. Prize money will be distributed at a ratio of at least 1 for every 7 entries or as determined by amount of entries. . In the event of a tie, prize money will be added for both places and split. Prize checks will be mailed to the listed address on the entry form. All tournament checks become VOID ninety (90) days after issuance.
5. **ENTRY FEE:** The entry fee will be \$50.00 per person per entry. Breakdown on Front Page.
6. **LANE ASSIGNMENT:** Lanes will be assigned by the Tournament Manager. Tournament Manager reserves the right to create additional squads, if necessary.

7. **OFFICIAL SCORE:** The telescore will be the official score during the game, and the official recap sheet will then be audited, and obvious errors will be corrected. Protests involving the scores or any other rules must be made before payment of tournament prizes. ALL BOWLERS WILL BOWL WITH A 9 PIN NO-TAP SCORING. **Only Tournament Workers May Change Scores.**
8. **AVERAGE ADJUSTMENT:** The tournament manager reserves the right to adjust any bowler's average prior to participation where there is evidence his or her average does not represent the bowler's true ability. USBC Rule 319E WILL APPLY to all bowlers.
9. **PREMATURE TERMINATION:** Premature termination of the tournament brought on by war, national emergency, or emergency causes relating thereto or therefrom, fire, national disaster, or any other reason beyond the control of the Upper Shenandoah Valley USBC shall cause, to the extend required thereby, all advertised prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants in each of the respective events up to the time of such termination.
10. **The Upper Shenandoah Valley USBC has the right to refuse an entrant and may request social security numbers where a possible 1099 may be issued for winners.**
